General Fund Transfers by the Tax Commission for the sixth month of the Fiscal Year ending June 30, 2006 were \$333,068,510 which is an increase of \$39,415,764 or 13.42% over the prior period. Transfers to all funds for the sixth month of the Fiscal Year ending June 30, 2006 were \$505,649,350 which is an increase of 43,696,407 or 9.46%.

General Fund Transfers for the month of December were over the estimate by \$25,403,327 or 8.26%.

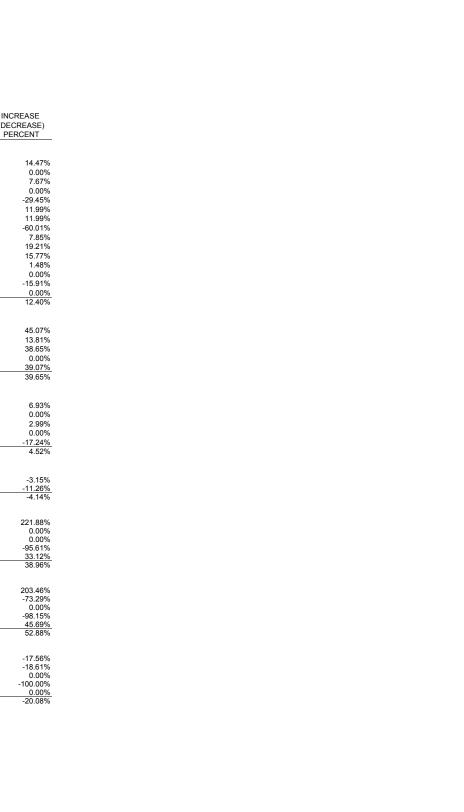
