General fund transfers by the Department of Revenue for the 10th month of the fiscal year ending June 30, 2019 were \$862,242,615 which is an increase of \$109,776,554 or 14.59% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending April 30, 2019 were \$4,547,110,851 which is an increase of \$234,589,832 or 5.44% from the same period of the prior year.

Transfers to all funds in the month of April for the fiscal year ending June 30, 2019 were \$1,106,858,696 which is an increase of \$102,353,788 or 10.19% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending April 30, 2019 were \$6,714,716,937 which is an increase of \$245,210,620 or 3.79% from the same period of the prior year.
