### **Mississippi Department of Revenue** Summary of Transfers April 2020

General fund transfers by the Department of Revenue for the 10th month of the fiscal year ending June 30, 2020 were \$568,378,541 which is a decrease of - \$293,864,074 or - 34.08% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending April 30, 2020 were \$4,414,109,106 which is a decrease of - \$133,001,745 or -2.92% from the same period of the prior year.

Transfers to all funds in the month of April for the fiscal year ending June 30, 2020 were \$786,566,373 which is a decrease of -\$320,292,323 or -28.94% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending April 30, 2020 were \$6,668,005,114 which is a decrease of -\$46,711,822 or -.7% from the same period of the prior year.
