Transfers to all funds for the 12th month of the Fiscal Year ending June 30, 2013 were \$855,246,205 which is an increase of \$6,589,374 or .78% of the prior year.

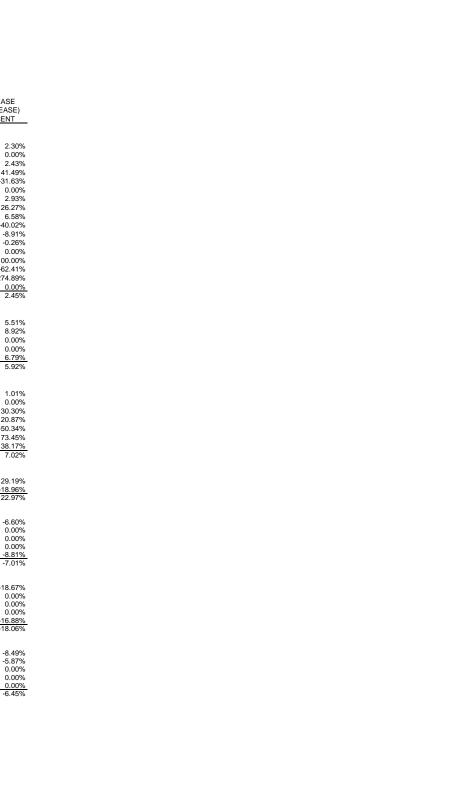
