General fund transfers by the Department of Revenue for the 12th month of the fiscal year ending June 30, 2021 were \$723,341,564 which is a decrease of -\$28,539,405 or -3.8% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending June 30, 2021 were \$6,556,969,247 which is an increase of \$952,511,335 or 17.% from the same period of the prior year.

Transfers to all funds in the month of June for the fiscal year ending June 30, 2021 were \$982,732,197 which is an increase of \$79,481,994 or 8.8% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending June 30, 2021 were \$9,477,320,370 which is an increase of \$1,270,331,771 or 15.48% from the same period of the prior year.
