#### Mississippi Department of Revenue Summary of Transfers October 2020

General fund transfers by the Department of Revenue for the 4th month of the fiscal year ending June 30, 2021 were \$522,670,949 which is an increase of \$17,476,239 or 3.46% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending October 31, 2020 were \$2,010,651,464 which is an increase of \$264,387,913 or 15.14% from the same period of the prior year.

Transfers to all funds in the month of October for the fiscal year ending June 30, 2021 were \$753,354,814 which is an increase of \$39,879,476 or 5.59% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending October 31, 2020 were \$2,929,921,371 which is an increase of \$318,967,230 or 12.22% from the same period of the prior year.
