### Mississippi Department of Revenue Summary of Transfers February 2022

General fund transfers by the Department of Revenue for the 8th month of the fiscal year ending June 30, 2022 were \$405,907,923 which is an increase of \$65,901,457 or 19.38% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending February 28, 2022 were \$4,231,044,618 which is an increase of \$423,879,346 or 11.13% from the same period of the prior year.

Transfers to all funds in the month of February for the fiscal year ending June 30, 2022 were \$750,976,362 which is an increase of \$123,299,038 or 19.64% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending February 28, 2022 were \$6,302,603,606 which is an increase of \$631,718,087 or 11.14% from the same period of the prior year.
