General fund transfers by the Department of Revenue for the 11th month of the fiscal year ending June 30, 2022 were \$654,161,814 which is an increase of \$22,154,322 or 3.51% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending May 31, 2022 were \$6,444,612,241 which is an increase of \$610,984,558 or 10.47% from the same period of the prior year.

Transfers to all funds in the month of May for the fiscal year ending June 30, 2022 were \$930,296,339 which is an increase of \$7,928,520 or .86% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending May 31, 2022 were \$9,396,864,941 which is an increase of \$902,276,768 or 10.62% from the same period of the prior year.
