Instructions

Estimated Tax Payments

Every corporate taxpayer having an annual income tax liability in excess of \$200 must make estimated tax payments. This voucher, 83-300, should be used to remit estimated tax payments for corporations. Composite S corporations and composite partnerships use Form 84-300, Pass-Through Entity Income Tax Voucher. Partnerships that elect to withhold and remit 5% of the partnership's net gain/profit to each partners' tax account should use Form 84-387, Partnership Income Tax Withholding Voucher.
