The form number is 80-115.

This form is to be **RETAINED BY THE ELECTRONIC RETURN ORIGINATOR (ERO) for a period of three (3) years**. It does not require barcodes or registration marks. This form is a supporting schedule for the Individual Income Tax return. This form should be a reasonable reproduction of the example provided, but small variations are acceptable. This form must be approved by the Mississippi Department of Revenue.

Any amounts in the form should be rounded and show whole dollars only.
