If a credit is claimed for tax paid to another State, there must be attached to the Mississippi income tax return a copy of the income tax return filed with the other State and proof of payment of tax there. A copy of the Wage and Tax Statement indicating tax withheld is not considered proof of payment of the liability to another State.
