The Mississippi Department of Revenue (referred to as “DOR” or “Department”) solicited bids for **Transfer Pricing Subscription** to purchase a subscription agreement for transfer-pricing for our Corporate Tax Division in our Clinton Office located at 500 Clinton Center Drive. The expiration date for this service is August 1, 2027.

DOR will contract for these services with a single vendor for a term of thirty-six (36) months.

DOR released the Transfer Pricing Subscription Invitation for Bid (IFB) # 3160006614 on May 30, 2024. DOR received one (1) bid submitted via mail in response to this IFB. The bid was submitted by the following bidder:

The bid submitted by EdgarStat LLC was evaluated and deemed responsive and responsible according to the criteria stated in the solicitation and was, therefore, ranked the highest.

We invite you to contact **Nyla Kendrick, Procurement Officer** if you would like to request a post-award vendor debriefing under Section 7-113 of the PPRB OPSCR Rules and Regulations. This debriefing is a meeting and not a hearing; therefore, legal representation is not required. However, if you prefer to have legal representation present, you must provide notification prior to the scheduled meeting so that we can also have legal representation present. Your request for debriefing must be received within three (3) business days after the issuance of this notice or no later than **July 3, 2024**. MDOR reserves the right to conduct any such debriefing via a teleconference.

Vendors are reminded that any protests of this decision must be submitted to **Nyla Kendrick, Procurement Officer** within seven (7) calendar days after the issuance of this notice or no later than **July 8, 2024**. The protest must be in writing, identify the name and address of the protestor, provide appropriate identification of the procurement and resulting contract number (if known), and detail the nature of the protest, including available supporting exhibits, evidence, or documents to substantiate any claims.

The successful vendor is instructed not to begin work, purchase materials, or enter into subcontracts relating to the project or services until execution of the contract.
