### **Mississippi Department of Revenue** Summary of Transfers August 2024

General fund transfers by the Department of Revenue for the 2nd month of the fiscal year ending June 30, 2025 were \$512,455,760 which is an increase of \$15,441,164 or 3.11% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending August 31, 2024 were \$1,072,202,662 which is a decrease of -\$6,177,178 or -.57% from the same period of the prior year.

Transfers to all funds in the month of August for the fiscal year ending June 30, 2025 were \$791,339,049 which is an increase of \$16,428,775 or 2.12% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending August 31, 2024 were \$1,680,092,742 which is an increase of \$19,041,297 or 1.15% from the same period of the prior year.
