Mississippi Department of Revenue Summary of Transfers September 2024

General fund transfers by the Department of Revenue for the 3rd month of the fiscal year ending June 30, 2025 were \$690,496,947 which is an increase of \$9,922,619 or 1.46% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending September 30, 2024 were \$1,762,699,609 which is an increase of \$3,745,442 or .21% from the same period of the prior year.

Transfers to all funds in the month of September for the fiscal year ending June 30, 2025 were \$994,914,417 which is an increase of \$37,009,724 or 3.86% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending September 30, 2024 were \$2,675,007,160 which is an increase of \$56,051,021 or 2.14% from the same period of the prior year.
