General fund transfers by the Department of Revenue for the 4th month of the fiscal year ending June 30, 2025 were \$620,891,193 which is an increase of \$10,317,264 or 1.69% from the same month of the prior year. General fund transfers for the fiscal year-to-date ending October 31, 2024 were \$2,383,590,801 which is an increase of \$14,062,705 or .59% from the same period of the prior year.

Transfers to all funds in the month of October for the fiscal year ending June 30, 2025 were \$962,962,152 which is an increase of \$70,801,473 or 7.94% from the same month of the prior year. Transfers to all funds for the fiscal year-to-date ending October 31, 2024 were \$3,637,969,359 which is an increase of \$126,852,542 or 3.61% from the same period of the prior year.
